#### **FY23 TOTAL ALLOCATIONS - Reminder**

For FY 2023 local agencies received their **TOTAL** Basic ILP (BL-862) and ETV (BL-861) allocations at the beginning of this fiscal year in June 2022.



We **strongly** encourage agencies that do not anticipate using all of their remaining Chafee and/or ETV funds by the end of the fiscal year (May 2023) to return any portion funds as soon as possible. Returning funds sooner than later allows VDSS to provide financial support to youth in localities that could benefit from additional funds.

## **VDSS and Child Trends Adoption Study**

## Child Welfare Capacity Building Collaborative - Authentic Youth Engagement Video


**Corey and Kristopher's Story**
