Foster Care Maintenance Payments

The General Assembly did not pass a full budget during the 2023 session. As a result, foster family home and adoption subsidy rate increases included in the Governor's budget were not approved. Foster care maintenance rates did not increase on July 1, 2023, as expected. The previous rates remain in effect.

Independent Living Stipends vs Fostering Futures Maintenance payments.

Please refer to *Foster Care Guidance 6.15* for additional information regarding when to use an IL Stipend. The IL Stipend and the Fostering Futures Maintenance payments are <u>not</u> one in the same. The Fostering Futures Maintenance Amount is included in the 13 and older foster care maintenance rate. (\$772.00)

An IL Stipend should be used when a youth 16-17 are residing in an IL arrangement. Examples of and IL arrangement could include but not limited to, living in their own apartment (separate from an IL apartment program), dorm, renting a room...)

A CANS is required for those youth that receive an IL stipend paid for through CSA funds. Payment cannot be made from title IV-E.

Housing Support Program Broadcast-HB 349 Housing Support

Housing Support Communication Forms are coming in! Please remember to discuss the Housing Support option with all eligible youth.

House Bill 349 – directs LDSS to provide housing support to youth who turn 18 in foster care on or after July 1, 2022, and are not participating in Fostering Futures. LDSS should notify all youth that would have been eligible to receive assistance as of July 1, 2022, of this eligible support. LDSS will need to submit completed Housing Support Communication Forms, found on FUSION Foster Care Forms, to va.ilp@dss.virginia.gov to receive approval for each individual youth requesting housing support. Funding assistance with be transferred to Budget Line 869 via LASER after each individual housing support request.
