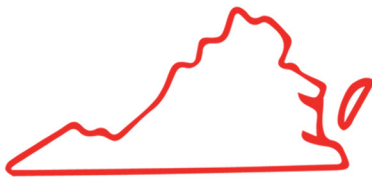

WHAT'S NEW

Single Statewide Foster Care Specialty Plan (FCSP)

- Anthem HealthKeepers Plus has been selected as the Foster Care Specialty Plan.
- All individuals with **Former Foster Care** Medicaid eligibility will automatically be enrolled in Anthem HealthKeepers Plus.
- You will have the choice to Opt-Out of the FCSP and choose a different health plan.

WHAT'S NOT CHANGING

Medicaid Enrollment: Youth will continue to be enrolled in Medicaid as long as they remain eligible.

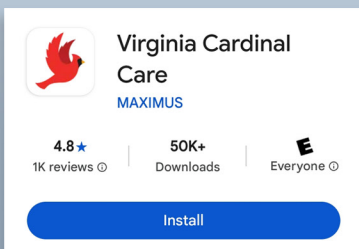
Benefits and Services: Benefits will not be interrupted as long as the individual remains eligible for Medicaid.

WHAT DOES THIS MEAN FOR YOU?

Within the next 30 - 60 days you will receive a FCSP assignment letter with additional information.

If you choose to Opt-Out, you will not have access to the extra benefits offered by the Foster Care Specialty Plan, including:

- A dedicated Foster Care Specialty Support Line active upon enrollment (Mon-Fri 8am-5pm, 833-838-2605).
- Individualized Care Management support including Transition Age Youth (TAY) liaisons to assist with independent living needs, childcare, and more.
- Options to receive luggage for travel, a Chromebook for learning, and support for employment needs such as certifications, attire, or tools.



Until the Foster Care Specialty Plan enrollment, members will continue to receive managed care coverage and services through their current health plan.
